What you need to do

You can make personal (after tax) contributions into your Child Care Super account by BPAY®, cheque or payroll deduction.

BY BPAY® – You can obtain the BPAY® biller code and your BPAY® Reference Number by calling the Member Services Team on **1800 060 215** or by logging into Member Online at **childcaresuper.com.au**. You do not need to complete this form if you make a contribution by BPAY®, simply make the payment via your bank or financial institution.

BY CHEQUE – Complete this form and mail with your cheque made payable to: **Child Care Super, GPO Box 2788 Melbourne VIC 3001**.

BY PAYROLL DEDUCTION – Complete the payroll deduction form available at **childcaresuper.com.au** and give to your employer.

Complete this form if you want to make a one-off member personal contribution by cheque.

Important Information: there are limits on the amount of contributions you can make before penalty tax may apply. Please refer to the *How Child Care Super Works Guide* at **childcaresuper.com.au/pds** or visit **ato.gov.au** for details.

* Your contribution will be treated as a non-concessional (after tax) contribution unless you provide us with a notice of your intention to claim a tax deduction in relation to the contribution. Tax deductible contributions are treated as concessional (before-tax) contributions. To claim a tax deduction you must send Child Care Super a *Notice of intent to claim or vary a deduction for personal super contributions* form available from the ATO website or by calling the Member Services Team on **1800 060 215**.

Any contribution you claim a deduction for will count towards your concessional contribution cap.
